**VOLUNTARY ANNOUNCEMENT
SALES VOLUME IN MARCH 2013**

This is a voluntary announcement made by Geely Automobile Holdings Limited (the “**Company**”).

The board of directors of the Company (the “**Board**”) is pleased to announce that the total sales volume of the Group for the month of March 2013 was 47,886 units, an increase of approximately 16% over the same period last year and up approximately 52% from February 2013. The total sales volume in the first quarter of 2013 was 142,886 units, up 21% from the same period last year and achieving 26% of the full year sales volume target of 560,000 units in 2013.

During the month of March 2013, the Group’s sales volumes under “Emgrand”, “Englon” and “GLEagle” brands were 15,807 units, 14,992 units and 17,087 units, respectively. The aggregate sales volume of GX7 and SX7, the Group’s Sport Utility Vehicles (SUVs), was 5,001 units in March 2013.

Please note that the sales volumes above are unaudited figures and have not been confirmed by the Company’s auditors and may be subject to adjustment and final confirmation. Shareholders and potential investors are advised to read carefully the financial results of the Group when it is published.
