TOTAL SALES VOLUME FOR MARCH 2025 WAS 232,177 UNITS
TOTAL SALES VOLUME UP 54% YOY

(HONG KONG, 1 April 2025) --- Geely Automobile Holdings Limited ('Geely Automobile'/the 'Group')(Stock codes: 175 (HKD counter) and 80175 (RMB counter)) announced that the total sales volume of the Group during the month of March 2025 was 232,177 units of vehicles, representing an increase of approximately 54% from the same period last year. Save for the sales volume disclosed above, during the month of March 2025, Proton achieved a sales volume of 13,575 units of vehicles, representing a decrease of approximately 1% compared to the same period last year. Further, in the first three months of 2025, the cumulative sales volume of Proton reached 37,938 units of vehicle, representing a decrease of approximately 12% compared to the same period last year.

Therefore, from October 2024 onwards, the Group has been consolidating Geometry's sales figures into Galaxy's and has made retrospective adjustments to the historical data for the same period.
